Help EMSAC to amend or defeat HB21-1251, "Appropriate Use of Chemical Restraints." Contact the Colorado House Judiciary Committee and ask the members to vote NO on HB21-1251, "Appropriate Use of Chemical Restraints."

HB12-1251:-

• Establishes an undue and impractical burden on EMS paramedics to weigh patients in an emergency setting before administering any weight-based medication dose. Numerous studies have shown that estimating patient weight—the only practical method—in an emergency setting is safe and effective

• Requires an unreasonable and unsafe burden on EMS paramedics to obtain direct approval from a registered nurse who does not have prescriptive authority, licensed physicians, or ambiguous "other authorized staff person" before administration of ketamine to patients in need of emergency sedation.

• Undermines the appropriate representation of medical experts on the EMPAC—EMS physician Medical Directors—by replacing those positions with non-EMS representatives.

• Does not create rulemaking authority for the Colorado Department of Public Health and Environment (CDPHE) to establish clear rules and definitions because it contains many ambiguous or undefined terms such as "justifiable emergency" and "nonhospital setting."

• It undermines, subverts, confuses and erodes the authority of CDPHE to establish rules pertaining to the scope of practice of EMS Paramedics.

EMSAC is working to secure payments for services rendered when dealing with a patient that ultimately is not transported. Agency directors, please take this short and simple <u>survey</u>.




EMS Funding Update



Colorado Senators Zenzinger and Liston (EMSAC's 2019 EMS Legislative Champions) were successful in amending the Colorado state budget to increase Medicaid reimbursement rates for emergency medical transportation by 2% on a vote of 20-15. It's relatively rare for

budget amendments to actually pass on the floor! Senator Zenzinger read the <u>Op/Ed penned by EMSAC President Scott</u> <u>Sholes</u> at the microphone. Thank you Senators Rachel Zenzinger and Larry Liston! Again!

AHA Publishes New Recommendations for Transporting Stroke Patients

The American Heart Association (AHA) has published new recommendations for prehospital triage and transport of stroke patients. A consensus statement, developed through the Prehospital Stroke System of Care Consensus Conference and published in the AHA journal Stroke, outlines guiding principles for determining transport destinations in rural, suburban and urban communities.



USAMRIID Pocket Guide Available to First Responders

The US Army Medical Research Institute of Infectious Diseases (USAMRIID) has created a (FREE) app based on a pocket-sized handbook that is given out at the MCBC course that USAMRIID Hosts (Medical Management of Chemical and Biological Casualties course). The course, pocket reference guide to bio-agent / toxins and the APP are for military and civilian clinicians and anyone out in hospitals or emergency first responders. New App Provides Emergency Response Vehicles with the Fastest, Safest Path to Incident Scenes

For first responders, there can be drawbacks to using "off-theshelf" consumer apps and following the same routes as everyone else. The apps may not take into account specific factors that can delay response time, like weather events, traffic accidents, or the size and weight of their vehicles. They also do not take into account Emergency Medical Services Association of Colorado - Administration

local roadway or speed limit rules for emergency vehicles. That's why the Department of Homeland Security <u>Science and</u> <u>Technology Directorate</u> (S&T) and partner Azimuth1, LLC are developing a solution, an app called <u>QuickRoute</u>.



FEMA Updates EMS Credentialing in Resource Typing Library Tool

The Federal Emergency Management Agency (FEMA) recently published minimal updates to its Resource Typing Library Tool (RTLT), used to requested EMS mutual aid resources under NIMS. FEMA updated the EMS references to the National EMS Scope of Practice Model (to the 2019 version) and noted that Advanced Emergency Medical Technicians may not be available in all jurisdictions. The RTLT is an online catalogue of national resource typing definitions, position qualifications, and Position Task Books provided by the National Integration Center at <u>https://rtlt.preptoolkit.fema.gov/public</u>.
