

COVID Protocol for Colorado State EMS Conference

All attendees, sponsors, exhibitors, speakers, staff, and volunteers must submit proof of COVID vaccination in order to attend the conference. Here are a few ways you can submit your vaccination record:

1) Upload a copy while registering. If you have already registered, contact us with a copy and we can update your registration record. You will receive a discount code and link to register in a couple of weeks via email.

- 2) Upload a copy during the session selection process
- 3) Bring a photocopy with you to provide during on-site registration

Anyone needing an exemption due to a medical condition, disability or religious belief will need to complete the exemption form and bring the signed form along with proof of a negative COVID test (molecular, PCR or antigen) that was administered by an official testing center to the event. The test must be taken no more than 48 hours prior to arrival at the conference center. Home testing kit results will not be accepted for entry.

Randy Kuykendall's Retirement



Public Emergency Medical Services Supplemental Payment

The **Public EMS Supplemental Payment** allows eligible EMS agencies to receive an annual supplemental payment for the uncompensated costs incurred by providing ground or air emergency medical transportation services to Medicaid beneficiaries. HHS PRF Tranche 4: Important Funding Opportunity for EMS Providers

This funding opportunity will distribute \$25.5 billion in additional Phase 4 General Distribution for EMS agencies and American Rescue Plan (ARP) payments for qualified rural providers who furnish services to Medicaid/CHIP and Medicare beneficiaries. It is critical for **all** EMS providers to apply for this funding opportunity regardless of previous funding allocations. We have learned that many EMS providers did not apply for the Tranche 3 funding opportunity because they did not believe that they would be eligible to receive funds under the announced funding formula. Report EMS Sentinel Events

In the continued effort to improve EMS provider and patient safety, the SEMTAC Safety Committee asks EMS providers to **report** sentinel events using EVENT (EMS Voluntary Event Notification Tool). EVENT is a platform that allows an individual or organization to anonymously report misses and near-miss occurrences, resulting in system improvements.



Colorado EMS Provider Licensing

Converting your Colorado EMS provider certification to a license is optional. If you choose not to convert your certification to a license, you will remain certified and will be able to renew your certification as you always have. Converting to a license does not change your scope of practice or the duration of your certification/license. For those wishing to be licensed, you can convert your certification by completing the license conversion form found in your OATH account or by choosing the license option in your next renewal application. There is no additional cost associated with license conversion.
