Public Health Event Levels

DESCRIPTION

- 1) The purpose of guideline is to provide guidance of the protection, education, and information descemination based on the severity of the current Public Health Event. Daily operations are at the descression of the agency and this is a recommendation from the medical direction to support the provider and agency protection and safety.
- 2) Providers will still be required to continue with yearly CE requirements in spite of these events. Every attempt will be made after completion of the event to make up education missed during the event.
